### **Privacy Policy for CZKC Faucet**

Effective Date: December 5, 2024

This Privacy Policy outlines how the website <a href="https://test.czkc.cz/">https://test.czkc.cz/</a> (hereinafter referred to as the "Operator"), collects, uses, and protects user information. Data may be processed to comply with GDPR or other applicable legal requirements.

# 3. Legal Basis for Processing Data

We process personal data based on:

**User Consent:** Users provide consent by entering their email address and accepting this Privacy Policy.

**Legitimate Interest:** To enhance Site functionality and performance during the testing phase. **Legal Obligation:** To comply with GDPR and other applicable data protection regulations.

# 4. Data Sharing and Storage

### 4.1 Data Retention

Email addresses and other personal data are stored securely and retained only as long as necessary for the purposes stated in this policy.

## 4.2 Third-Party Access

The Operator does not share personal data with third parties unless required by law.

# 5. Your Rights (GDPR Compliance)
